Annotated Version by Amy Sherlock

October 27, 2025

The following recently discovered SMS text messages are between Stephanie Hess (Grey Highlighted) and me, Amy Sherlock (Blue Highlighted). They occurred from May 2017 through January 2024. Hess had worked for my husband, Michael "Biker" Sherlock as a Personal Assistant/Bookkeeper for approximately 15 years. She was also personal friends with me and my brother-in-law Steve Lake.

The content relates to Biker's alleged suicide on December 2, 2015, and the Conditional Use Permits ("CUP") he had just acquired for the operation of marijuana outlets in the City and County of San Diego.

The text messages shown are in reverse order with the most recent on Page 001. Pages should be read beginning at the last page, starting at the bottom of the page. My italicized comments, and relevant links to my comments are shown in RED.

With Hess's relationships with Biker, his partners Adam Knopf, attorney Gina Austin, my brother-in-law Steve Lake. David Chadwick, Renny Bowden and Brad Harcourt at the 8863 Balboa CUP, Hess had inside knowledge of the joint venture relationships between these parties and how the CUP application for 8863 Balboa was processed by the City.

I understand. It totally fucking hurts. Nobody has bigger wounds than Biker, me and our boys. I'm not going to let them get away with it. I love you too and I'm thankful for the friendship we've all shared. I have an amazing psychic and Biker is grateful for taking away his shame and fighting for the truth and what opportunities my boys would've had had they not stolen them.

It's just really hard to take in. I love you and I'm thankful I have you all in my life. You will always be in my thoughts and prayers. I do appreciate you sharing what you know, I want to know but every time it opens that wound. You know that much more than me but it's crushing.

These messages are critical to understanding the roles of Lake, Harcourt, Biker and Hess once the 8863 CUP was approved,

Hess worked as the bookkeeper for the 8863 dispensary until October 2015 when she was let go because according to Lake, they ran out of money. Biker died by an alleged suicide within months of her departure. This left the dispensary to Lake and Harcourt and nothing for me and our sons.

The document being referred to here was the 11/30/2022, ARMOROUS REPORT. This is one of two 3rd party forensic analysis I had done in researching Biker's death. The second report was the 11/28/2023, RODER REPORT.

One of Biker's business partners at the Ramona CUP was Duane Alexander. After being screwed over by Lake for years after Biker's death, Alexander reached out to Flores and gave a statement surrounding the events regarding Biker's ownership interests and Lakes relationship with his death in the 02/26/2024, ALEXANDER REPORT.

Thank you for your input. I really do appreciate it. I realize how solid I am with the facts and you're honestly the only person that I cared to make sure you knew the facts since it's so complicated. I know people will defend them in the beginning. They will be put on the stand to explain themselves. I will not stop until that happens.

At the time I was making these texts in 2024, I recognized that this was a complicated case. That those who benefited from Biker's death after his CUP's had been approved, were not only hypocrites for insisting they not have their names on the CUP applications but were setting Biker up for what would be their takeover, by whatever means necessary, of these high value, all-cash dispensaries once Biker had acquired them.

They didn't want to put it in their names because they're hypocrit - Steve is still saying he's not and never has been in the business. I don't know why anyone would lie at all especially about your benefit from the dead guy. Why lie to the police to throw them off from an investigation? I know the reason. It's obvious.

Biker had zero experience filing a CUP application. He relied entirely on consultants, the so-called experts, such as Gina Austin and her partner-in-crime, Jim Bartell for this process.

I was just sharing my thoughts since I was there, living the day to day back then with all three. I don't know why they lied. Just like I don't know why they didn't just put the cup in their name if they wanted it that bad. Like I said, the cup wasn't the companies biggest gain. 1.5 million doesn't even cover their costs, when keeping it and having Biker around would have made an incredible profit. The risk would have been greater than the reward. I don't get it. I hope the truth comes out. Most lie when they're covering something up or scared...sounds like those scenarios were both in play. What reason I wish I knew.

Dr. Mark Cooper, a child psychologist, was a neighbor and friend of Lake's who following Biker's death, Lake brought him to the house to "help" the family come to terms with what Dr. Cooper believed were the classic symptoms of CTE brain injury from Biker's years of sports related head trauma. Dr. Cooper, with no experience in CTE injury, opined that this trauma resulted in Biker's decision to commit suicide.

In hindsight, with what Lake contributed to the Police Report, with Lake going to the trouble to bring Dr. Cooper to a grieving family, and Lake's numerous contradictions in narrative during years of litigation, I am left to believe that the circumstances surrounding Biker's death and the subsequent transfer of those CUP interests bypassing me have not even begun to be exposed.

On [July 30, 2022 Dr. Mark Cooper](#) had his medical license revoked.

On [September 7, 2022, Mark Cooper](#), 57, dies of unknown causes.

I was there, Steve or Brad could have easily put the Cup in their name. It was up for discussion, but Biker finally just said he'd do it. If either wanted it, they could have had it no issue. Biker suggested Brad too, just as he suggested me. Just someone they could trust.

Here, Hess's comments seem to prove that neither she or Biker were legally sophisticated enough to understand the mandatory disclosure laws. They were manipulated, as has been seen in other Austin/Bartell-guided CUP applications.

Austin and Bartell collaborated with City officials in schemes whereby applicants would act as proxies ("Strawman") for undisclosed owner interests. These strawmen were led to believe their actions held NO legal consequences.

The facts speak for themselves and that's all I have and whatever lies they said to cover it up. Answer this. Why'd I get nothing? Why'd they lie? You know Harcourt never even paid his respects? I don't know who killed him but they are going to have to answer for fraud.

As I've stated throughout my comments, this CUP was ALWAYS Biker's dream and passion! It was the groups shared goal that Biker's name, his fame, would be the engine that drove these dispensaries success. It was Biker, before he had had any relationship with Austin, Bartell, Knopf, Chadwick or Harcourt that stood near the front of the [massive line at the City, early in the morning of January 2015](#), when these applications were first made available. Biker was NEVER an anonymous participant in this process. The dream of owning a Biker Sherlock CUP was always his. A dream he took to his grave. Hess is lying here to protect those who were responsible for stealing that dream.

Neither had enough to lose that it would ruin them, even hurt them if everything went sour. So why such drastic measures? That's where it feels like something else had to be going on. We had the Ramona buildout, the balboa cup and was looking into other opportunities, lots. That cup was not the only thing we had going on by far. Both myself and Darryl Cotton ("we/our") have had over 5 years of ongoing communication with the San Diego FBI field office, Public Integrity Unit Special Agents (SA") and despite all the solid evidence that we and others introduced to the SA's investigating the municipal pay-to-play corruption we found, they never took any action on our behalf.

In our [January 27, 2025 letter to Inspector General Michael Horowitz](#), we provided the first in a series of letters that would elevate these conditions to the Washington DC federal level attention. To date, we have had no responses from the DC DOJ or FBI.

I wish to make it very clear here that I always wanted to pursue Hess through discovery so as to have her on the record. On July 7, 2022, I sent my attorney, Andrew Flores and my litigation investor, Joe Hurtado an email which memorialized a phone conversation we all had with Hess. That email memorialized the issues which were discussed. I stayed on both Hurtado and Flores about getting Hess on the record until eventually they told me that "**We don't need her.**" I'm not a lawyer so even though I've never been happy with the slow pace, the numerous missed and late filings they've put me through, it is now, when reading these texts and making my comments I am furious that my own legal "team" was either too lazy or complicit in this to pick up on investigating ANY Hess discovery that would have helped rip open the lies that have come from Lake, the only defendant we've seen ANY discovery from in 5 YEARS OF LITIGATION! In fact most of the original defendants have not even been served and have, under court order, been dismissed! To say I'm furious with Hurtado and Flores in my past legal representation and how they have added to my pain and suffering through all of this, would be an understatement of epic proportions!

When considering these comments it's important to consider the way Austin/Bartell processed Bikers 8863 Balboa CUP when compared to to the Geraci/Berry 6176 Federal CUP where Berry was used as a proxie, a strawman, (See the [Berry Trial Transcript, at Pg's. 190-200](#)), expressly because Geraci could not be disclosed on the CUP application because Geraci had been [previously sanctioned](#) for owning and operating unlicensed dispensaries in the City.

When considering the distinctions between Biker and Berry's CUP applications it must me noted that Berry admits to hiding the interests of Geraci in his application. Biker not only stood front in center in the process, attending the various hearings, he did all of this under the experienced consultation and direction of Austin and Bartell. Berry was a strawman. Biker was not.

The elements for having reached their decision to murder Biker can be seen at the SAME 8863 Balboa property where Salam Razuki (an undisclosed owner) hires a hit man to kill his CUP partner Ninus Malan (NM) who, refused to concede his rights to Razuki's undisclosed ownership interests.*

The truth does matter but not other's opinion of it. If they think head trauma and suicide is for cowards and losers then they have not seen that kind of loss. Unfortunately, for me...I've seen it too many times over. Those kind of people Don't Fkn Matter.

Meaning to walk away from the Balboa CUP. Which, if we're to track that "benefited" statement means the CUP transfers around me, which purported to act like they considered me in the transfers **had to involve Lake**, not me, in coordination with the City through DSD's Edith Gutierrez in an effort to **CONTINUE the business!** In other words you can't have it both ways Lake. The CUP was NOT a financial loss! You, Harcourt, Gutierrez, Austin, Bartell and others **KNEW** this. It is **WHY** the benefits were there and, as this dispensary is **STILL** in business 10 years later, the conditions that led to the murder, the theft and those who benefited, including those in the City who collaborated in these acts, must be held accountable! Several months after Biker's death, Harcourt (LERE) sold the 8863 Balboa property, which had also been Biker's (See the [LERE Articles](#)), to Lake (HSE). On the 04/13/2016 Preliminary Change of Ownership Report that Lake had to provide the change of ownership information and then sign and certify the information was correct, Lake checked every box except PART 1 (D), which requires a yes or no answer. Lake left both boxes blank. Every other answer on the form was provided. When asked if the property transfer was a result of a death, Lake deliberately left that answer blank. **This was not inadvertent omission because Lake initials and circles a box a few lines down from there where he had made an error.** (See the [04/13/2016 Preliminary Change of Ownership Report at 8863 Balboa Ave.](#))

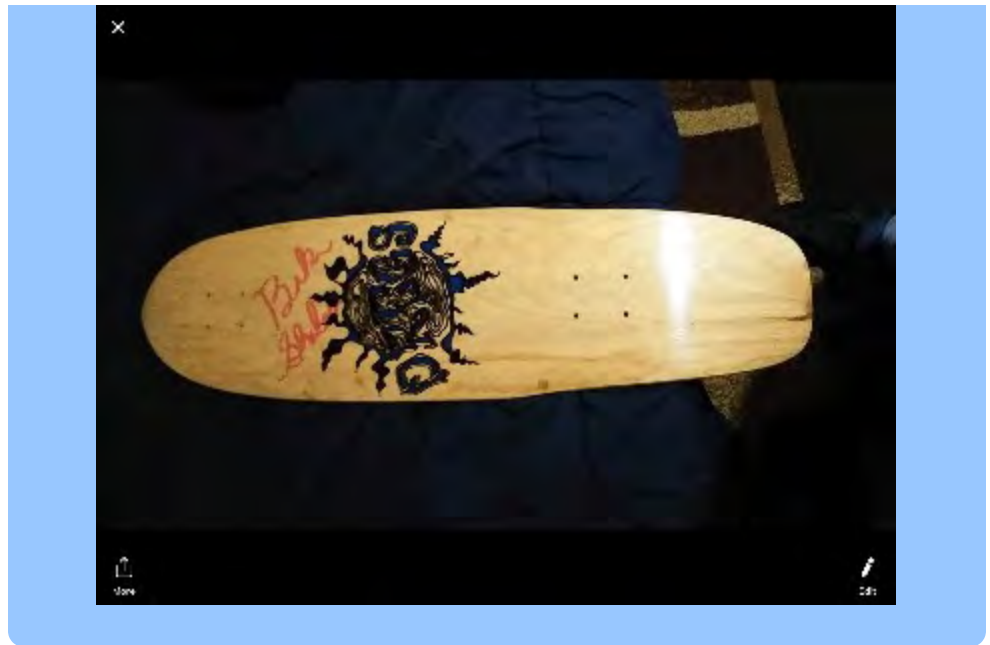
