SEVENTH AFFIRMATIVE DEFENSE

(Waiver, Estoppel, Res Judicata, Latches and Unclean Hands)

As a seventh separate affirmative defense to the Complaint, and to each and every cause of action contained therein, Plaintiffs' claims are barred and whole or in part to the extent the doctrine of waiver, estoppel, res judicata,

latches and/or unclean hands apply.
