### Officer's Statement:

On 06-10-17 at 1046 hours, Officer Gibson #6849 and I responded to 6176 Federal Blvd to investigate a robbery that had occurred (see Officer Gibson's crime report). We arrived on scene and I contacted Darryl Cotton (identified via CDL). He essentially stated the following:

### Statement of Darryl Cotton (victim, witness):

Cotton said he was returning back to his business after depositing money at the bank. When he arrived he noticed the door to his business was not open, which was unusual. He walked up and attempted to turn the knob but it was locked. He knew something wasn't right. He opened the door with his key. He saw Jeff lying face down on the floor his hands bound with duct tape behind his back. He saw a middle age black male standing next to him. He looked to his right and another black male was standing next to James's trailer with a silver handgun. The male pointed the handgun at him so Cotton ran back towards his truck and called 911. He was standing near the truck when he saw one of the males exit the front of the building. He was holding a large bag filled with their marijuana. Cotton was able to run up and "shoulder check" him into the fence. The male continued running west on 6100 Federal and got into a newer green colored SUV. Cotton was able to follow the SUV (CA # 7VLR320) east on Federal Boulevard. He believed the car was occupied by 2-3 people.

I contacted a female later identified as Anna Martinez. Martinez was initially at the scene however left quickly upon our arrival. I located Martinez hiding behind a vehicle at a nearby liquor store. I informed Anna she was being detained pending further investigation. She was initially uncooperative. I placed her in handcuffs and double locked and adjusted them for her comfort. Martinez eventually provided me with her information and gave me a brief statement. She essentially stated the following:

### Statement of Ann Martinez (witness):

Martinez said she pulled up in her car and got out. She said three males in all blue "new jump suits" wearing white bandanas were standing outside. She said they all had bags filled with marijuana with them. She said one of the males had a silver handgun but did not point it at her. She stated the subjects were "freaked out" and all ran different directions when they saw her. She immediately got back into her car and that is when police arrived. Martinez believes she has seen two of the males before "around the building". She believes she can identify at least one of them.

Martinez described the suspect with the gun to be a black male in his late 20's, around 5'8" with a skinny build. She said he was wearing a hat but "knew he had short hair". She said he had a silver

gun that was most likely a "9". Martinez was unsure what the other males looked like other than they were black males in their mid-twenties.

I took several photographs of the scene which were later uploaded onto a CD/R and impounded at Southeastern Division property room on barcode #10761655.

I placed latex gloves on and collected the duct tape that was used to bind Jeff Hagler. I impounded it at Southeastern Division property room on barcode #10761650.

Jeff Hagler informed me a set of ear buds may had been left behind one of the suspects. I placed a separate pair of latex gloves on and collected them. They were impounded at southeastern division property room on barcode 10761651.

I collected a DNA sample from Darryl Cotton. It was impounded at the Southeastern division property room on barcode #10761647.

I collected a DNA sample from Jeff Hagler. It was impounded at the Southeastern division property room on barcode #10761646.
