What I have provided you with here, is a somewhat complex chain of events and characters that all started from a small urban farm I ran growing traditional crops and cannabis under Prop 215 guidelines on a commercial property I own located here in San Diego. What is simple about all this was that in July 2016 I received an unsolicited offer to purchase my property from Mr. Larry Geraci. I told Geraci that the City of San Diego had rezoned my property so that it no longer qualified for one of these licenses but Geraci, an accountant and licensed real estate agent, told me he had a solution to that and wanted to discuss it in further detail with me. Since Geraci looked to be a successful and established businessman and I was interested in hearing more about his plans, I began meetings with him at his <u>Geraci Tax and Financial Center</u> offices.

Stay Awake. Stay Aware. My Story</u>. It was my intention to make everything, evidentiary wise to the complaints, easy for you and my extensive social media followers to find. I believe I have done so in Chapter 11 Section 11.9 of the Canna-Greed story.

As my Federal Case (18cv325) has now been lifted and additional complaints and evidence are soon to join mine, I wanted the CA- BAR to be aware of what has happened with both the attorneys who have represented me and those that have been adversarial to me. My intention was to give you the time and resources necessary to investigate the claims being made and take what appropriate action is deemed necessary.
