Hi John,

Thank you for taking my call earlier today with my partner Joe Hurtado. I'm glad to hear you're enjoying your retirement building a log cabin up in Utah. I'm happy for you.

As to the purpose for that call we agreed to not bombard you with the details, until my attorney Jacob Austin, can assemble the documents I will present to you that proves Aaron Magagna is part of a conspiracy to fraudulently deprive me of a CUP application at my 6176 Federal Blvd property and is using you and your property in an attempt to sabotage my application with the cooperation of the City of San Diego Development Services Department (DSD) being part of that scheme.
