Dear Mr. Cotton,

On January 18th we met in the hallway after your ex parte hearing and you agreed to allow access to the 6176 Federal Blvd. property for soils testing in connection with the CUP Application.

I have been informed by Abhay Schweitzer that the geotechnical consultant who will perform soils testing is required to file a permit with the San Diego County Department of Environmental Health because the exploratory borings exceed 20 feet below ground surface; in order to do so they require the signed consent of the property owner.

I have attached the required Property Owner Consent form for you to complete and sign and return to me so my client can complete the necessary soils testing in connection with obtaining the CUP. As we discussed previously, if a CUP permit is obtained, then it will "run with the land," so obtaining a CUP will benefit whichever party ultimately prevails in the litigation.

Please complete, sign, and return the Property Owner Consent form to me as soon as possible. Thank you.
