This is some fishy bullshit. This dispensary out of Sacramento is planning to expand into 5-6 other cities. including Red Bluff. They apparently think they're already approved and plan to open here in November.

Thank you for the forward, Kenn. I spoke with Jennifer Luna briefly and introduced myself. Told her we were the non-profit that have been pushing Red Bluff and Tehama County to open up to cannabis and hemp. When I steered the conversation to how they first heard about red Bluff opening up, se said they have contacts on our City Council. I asked if it was Clay Parker and she wouldn't say.

When I asked if they worked with HDL at all...her phone cut out. When I called back, it went to voice mail. Basically, she hung up on me when I mentioned HDL.

This changes everything. It means that Clay (or Scott) are trying to line up a specific dispensary to be streamlined here, before the City Council even agrees to anything. I'm guessing there is a financial relationship here that is not being disclosed. This is good old boy 101. It stinks to high heaven. How much money is being paid to Clay Parker (or Scott, etc.) to push this agenda and shut out all local applicants, before the ordinance is even finished? We need to call this out to the City Council, tonight!


