I'm forwarding this to the Committee, Council Members and concerned citizens. Please share with anyone I missed that is in this loop.

This is the latest revised draft that we sent to you all in early October, before the city council meeting. Please notice that we amended the draft to exclude all outdoor cultivation, as requested. We also made several other corrections, based on what Scott Friend had indirectly requested at the previous Committee meeting.

As you can see, we are dedicated to amending this draft ordinance based on the input of this Committee (including public comments) and the City Council of Red Bluff. Please review the language, at your convenience, and consider moving forward with additional edits during your Committee meetings, until we can achieve a final draft to present to the City Council. We have several commercial license categories to consider, as they relate to each zoning category. We also have personal (medical and adult use) cultivation guidelines to consider. There may even be additional language considerations, based on the input from each member of this Committee, and public comments. All in all, this ordinance should not be overly complex or too long to hold most peoples attention span. I firmly believe that we can achieve a final draft within the next few months, including holiday breaks, if this Committee commits itself to the review process. It's less than a dozen pages.

Please also review the link that Bob Halpin included, regarding California's new (2021) standards for ALL indoor commercial agricultural production. This will impact all cannabis cultivation projects, as they relate to CEQA and state permitting processes. For this reason, we strongly encourage this Committee to consider including Mixed Light cultivation standards for all commercial and personal cannabis cultivation within the City of Red Bluff. We can also still allow for purely indoor cultivation, but to not include provisions for mixed light standards might prove detrimental to the implementation of any ordinance this Committee produces.
