I filed this complaint seeking an Alternative Writ of Mandate against the City of San Diego so that I would have among other things, court protection of my property rights during the application process for a City of San Diego Conditional Use Permit being applied for on my property that was under the entire control of Larry Geraci who I was in litigation with over the sale of my property and the joint venture language he failed to reduce to writing. Geraci had a financial interest in seeing the CUP denied because he knew I was not going to sell the property to him. Where the City/Phelps failed me is that they had an obligation to tell the court the 3 sentence document that Geraci was claiming was a fully integrated binding contract. In their response the City/Phelps took the position they had no obligation to respond to the complaint and Judge Wohlfeil accepted that argument. This is absurd! A first year law student could look at that document and see that it wasn't a contract/agreement! Phelps failed in his obligations to the court in his response which helped perpetuate a fraud upon Cotton and the court.
