In his response Crosby agrees in Para 1 agrees that this entire case and all associated litigtion stems from a contract dispute being litigated between in Geraci v Cotton in state court (37-2017-00010073-CU-BC-CTL) on 03/21/17. Crosby then goes on to argue that the original 03/21/17 complaint F&B filed on behalf of Geraci was not a sham lawsuit and that it met all the criteria of what any first year law student would disagree with him on in that the 11/02/16 document was a fully integrated and binding contract that completely encompassed the mutual assent with all terms and conditions having been defined within that document. This is patently absurd as it was proven at trial in statements made by Judge Wohlfeil that the 11/02/16 document was not an agreement, that oral representations had been made that were not contained within the 11/02/16 document and that F&B provided a Disavowement Allegation a year after the case was filed while continuing to manufacture evidence that would support their ever evolving strategies in this case.
