In 2018 McElfresh went on to provide legal services for Geraci without seeking my waiver for that representation. I was and still am in litigation with Geraci. McElfresh is part of an enterprise of attorneys who work with the cannabis licensing in the City of San Diego. My federal case has been on a stay since February 2018 18cv325-BAS (MDD). I filed a motion to lift the stay on 12/23/19. Once that motion was filed two federal judges recused themselves from the case until the 3rd judge agreed to lift the stay on January 15, 2020. McElfresh is part of a group of attorneys who use the law as a sword to deprive citizens of their constitutional rights in the interest of acquiring these licenses for a select group of people. I have the evidence of this and will be presenting in federal court once I find a judge and jury that can be unbiased in this matter and look at the evidence I provide them. McElfresh should be disbarred for her actions
