

Geraci v Cotton: Disqualification Filings - Superior Court Screenshot of 01/29/2020

This is the **same document** but given two different ROA numbers; 715 and 717 which make it look like the DQ was filed on both 01/16/20 and 09/13/18 when in fact both documents were uploaded to the Superior Court website on 01/16/20, or 16 months after the court received them.

This is the **same document** but given two different ROA numbers 716 and 717 in an attempt to make the Proof of Service look like it was filed on 01/16/20 not 09/13/18 or 16 months after the court received them.

In addition to the issues being raised of giving the same document two different ROA numbers we can also see multiple reuses of the same ROA numbers for **different documents**. For example here you can see there are 3 entries for ROA 717. Why weren't these documents given different ROA numbers so they could be identified individually? It makes no sense.
