1 The Court has considered the briefing in support of, and in opposition
2 to, defendant Donald Campbell's Motion to Dismiss Plaintiff's Complaint, as well
3 as the briefing in support of, and in opposition to, the other defendants' motions
4 to dismiss. The Court **GRANTS** Campbell's Motion to Dismiss and **ORDERS**
5 Plaintiff's Complaint dismissed with prejudice. The Complaint does not allege a
6 claim under Federal Rule of Civil Procedure 12(b)(6).

7 Plaintiff does not state a TVPA claim against Campbell, and because
8 the alleged conduct did not involve "interstate commerce," the TVPA claim
9 is dismissed with prejudice.

10 As for the remaining state law claims for sexual assault and battery, each is
11 based on alleged conduct Plaintiff asserts took place in May 2013. California law
12 required Plaintiff to bring her assault and battery claims by no later than May 2015.
13 Plaintiff's state law claims for sexual assault and battery against Campbell are time
14 barred and dismissed with prejudice.
