The Court after reviewing papers filed and hearing oral argument confirms in part and takes under submission in part as follows:

The Motion (ROA # 491) of Defendant / Cross-Complainant Darryl Cotton ("Defendant" or "Cotton") for an Order that the Initial Answers of Plaintiff / Cross-Defendant Larry Geraci ("Plaintiff" or "Geraci") to Defendant's Interrogatories be Deemed Binding, is DENIED.

Defendant's Request (ROA # 492) for judicial notice is GRANTED IN PART and DENIED IN PART. The Court takes judicial notice of Exh's "1 and 10," and declines to take judicial notice o Exh's "2 - 9."

Plaintiff's evidentiary objections (ROA # 487) are SUSTAINED.

The plain language of the statute relied on by Defendant - CCP 2030.310 - contemplates that "an amended answer" has been served. Here, Plaintiff has not yet served an amended answer.

Plaintiff's request for sanctions is DENIED. Though a close call, the Court finds that Defendant did not file his Motion without substantial justification.
