Hi Lance,

Thank you for the generous amount of time you spent with me on the phone earlier. The reality for me is that there are not a lot of people out there that realize what's gone wrong with adult-use cannabis licensing in San Diego and speaking with you was somewhat cathartic.

As I said during our call, during your May 28, 2015 Planning Commission statement, you reference a letter you wrote to the Planning Commission relative to what you saw as violations of the Brown Act and the Open Government Act. That letter was not attached to the Report to the Planning Commission. If it's possible that you still have it and could send it to me I'd like to be able to reference it as one, if not the only time, I've seen it referenced by an attorney in the CUP application processing.
