I, Ethan Turner declare as follows:

- 1. I am an attorney duly licensed to practice law before the Courts of the State of California. I am one of the Deputy Attorneys General (hereinafter, "DAG") assigned to represent Plaintiff Department of Cannabis Control (hereinafter "Plaintiff" or "DCC") in the above-entitled matter. I have personal knowledge of the information set forth herein below, based on my own personal knowledge and belief that the following evidence, declarations, exhibits and writings are true and correct. If called as a witness in this proceeding, I could truthfully testify to the following:
- 2. On June 14, 2021, Plaintiff propounded discovery, including Requests for Admission, Set one on the following seven Defendants: Ruben Kachian, a.k.a. "Ruben Cross", Vertical Bliss, Inc., Kushy Punch, Inc., Conglomerate Marketing, LLC, More Agency, Inc., Arutyun Barsamyan, and Mike A. Toroyan. True and correct copies of Requests for Admissions are attached as exhibits to the Declaration of Deputy Attorney General Michael Yun in Support of Department of Cannabis Control's Motion for Summary Judgment. At the time, all seven Defendants were represented by Browne, George, Ross, O'Brien, Annaguey & Ellis, LLP (hereinafter, "BGR").
- 3. On July 19, 2021, Plaintiff agreed to a three-week extension of the due date for Defendants' discovery responses, making the due date August 9, 2021.
- 4. On July 27, 2021, Margarita Salazar (hereinafter, "Salazar") substituted in as counsel of record for Defendant Ruben Kachian. A true and correct copy of the substitution of attorney is attached hereto as **Exhibit 1**. Defendant Kachian has never provided any discovery responses.
- 5. On August 3, 2021, David Carroll of BGR, counsel for the remaining six
 Defendants—Vertical Bliss, Inc., Kushy Punch, Inc., Conglomerate Marketing, LLC, More
 Agency, Inc., Arutyun Barsamyan, and Mike A. Toroyan (hereinafter, "the six Defendants")—
 requested an additional two-week extension to provide responses. Plaintiff agreed to extend the

- 6. On August 17, 2021, counsel for the six Defendants requested an extension of the due date of discovery to October 18, 2021. Plaintiff again granted the extension.
- 7. On October 13, 2021, counsel for the six Defendants requested yet another extension of the due date of discovery responses to November 1, 2021. On behalf of Plaintiff, I offered an extension to October 25, 2021, and stated that there would be no more extensions.
- 8. On November 1, 2021, one week after the expiration of the fourth extension, responses to the requests for admissions that had been served on June 14, 2021, were received from the six Defendants. The responses comprised exclusively of boiler plate objections. True and correct copies of the RFA responses of Vertical Bliss, Inc., Kushy Punch, Inc., Conglomerate Marketing, LLC, More Agency, Inc., Arutyun Barsamyan, and Mike A. Toroyan are attached as Exhibits to the concurrently filed Declaration of Deputy Attorney General Michael Yun in Support of Department of Cannabis Control's Motion for Summary Judgment.²
- 9. On November 5, 2021, I sent an email to counsel for the six Defendants stating that the received responses did not meet the minimum standards required under the California Code of Civil Procedure.
- 10. On November 15, 2021, counsel for the six Defendants responded that he was continuing to make efforts to secure substantive responses to the Plaintiff's discovery requests. Regarding the boiler plate objections, counsel for the six Defendants stated the objections were served "simply to preserve them" and admitted that they "otherwise did not have verified responses to provide." A true and correct copy of the email is attached as **Exhibit 2**.
- 11. On November 23, 2021, counsel for the six Defendants indicated that he had been unsuccessful in securing any substantive discovery responses from his clients. A true and correct copy of the email is attached as **Exhibit 3**.
- 12. On December 21, 2021, Margarita Salazar (hereinafter, "Salazar") filed substitution of attorney forms and undertook the representation of the six Defendants in addition

to Defendant Ruben Kachian. True and correct copies of the of the substitution of attorney forms for Vertical Bliss, Inc., Conglomerate Marketing, LLC, Kushy Punch, Inc., More Agency, Inc. served upon counsel for Plaintiff are attached as **Exhibits 4, 5, 6, 7, 8, and 9**.

- 13. On December 21, 2021, I sent an email to Salazar to inform her that the discovery responses provided by the six Defendants under BGR's representation had failed to comply with the requirements of the Civil Discovery Act. In the correspondence, I included an email previously sent to prior counsel of record informing him of the same, and requested scheduling a meet and confer for December 22, 2021. A true and correct copy of the email is attached as **Exhibit 10**.
- 14. On January 4, 2022, I corresponded with Salazar and she indicated that she would be available for meet and confer on January 5, 2022. A true and correct copy of the emails are attached as **Exhibit 11**.
- 15. On January 5, 2022, Salazar, my co-counsel Deputy Attorney General Michael Yun, my supervisor Senior Assistant Attorney General Harinder Kapur, and I met and conferred via teleconference. During the phone call, Salazar stated she would speak with her clients on January 6, 2022. Salazar and Plaintiff's counsel agreed that the seven Defendants would provide the supplemental responses by noon on Friday, January 21, 2021. Additionally, the parties agreed that Salazar would send a follow up email to counsel for Plaintiff after her conversation with the Defendants on January 6, 2022, to re-confirm that supplemental responses would be turned over to counsel for Plaintiff as scheduled by noon on Friday, January 21, 2021. Following the meet and confer, I sent an email to Salazar to document and confirm the parties' agreement. A true and correct copy of the email is attached as **Exhibit 12**.
- 16. On January 12, 2022, having received no response from Salazar regarding supplemental discovery responses, I sent a follow up email to Salazar regarding outstanding discovery matters (1) to inform her again that I have not heard back from her, (2) to ask her for an update, and (3) to remind her that she agreed to provide the Code compliant supplemental responses by January 21, 2022. A true and correct copy of the emails are attached as **Exhibit 13**.
 - 17. As of January 26, 2022, Salazar had failed to provide any of the promised

Pursuant to the Court's order, Kachian's responses to Interrogatories were due six days ago, on January 20, 2022. Pursuant to representations you made in our January 5 conversation and in subsequent correspondence, you indicated that supplemental responses would be provided for your other clients to cure the defective responses that were previously provided, by January 21, 2022. Subsequently, you informed us that you needed time to provide responses and would have them to us by Monday, January 24, 2022.

As I previously indicated, the responses received from Vertical Bliss, Inc., Kushy Punch, Inc., Conglomerate Marketing, LLC, More Agency Inc., Arutyun Barsamyan, and Mike A. Toroyan were uniformly defective for the following reasons and have not been cured:

- 1. The answers given are not made under oath (Code Civ. Proc § 2030.210, subd. (a)).
- 2. No responsive information is provided (Code Civ. Proc. § 2030.210, subd. (a)(1)),
- 3. The objections are without merit and are too general (Code Civ. Proc., § 2030.300, subd. (a)(3));
- 4. All objections are made without connecting the questions to any "specific ground for the objection." (Code Civ. Proc., § 2030.240, subd. (b).)

With respect to Mr. Kachian, no discovery responses have yet been received. Also note, that pursuant to the Court's order, the RFAs sent to Mr. Kachian have all been deemed admitted.

If there is anything to discuss regarding any of these matters you may call me. However, I believe our prior conversations together with this email constitute adequate efforts to meet and confer prior to filing additional motions to compel, which we now intend to do.

Additionally, if your clients have any interest in taking part in mediation, which the Court ordered us to engage in, please respond to Mr. Levinson's email from yesterday and please execute the mediation agreement by the deadline he set.
