What anyone can see is that there was a real sense of "being gamed" by some on the Planning Commission and there were some who had no problem expressing their displeasure with the process. You were one who, when given the opportunity, demanded and voted for what would be an adherence to SDMC and fair transparency in who was behind some of the more preferential treatment i.e. The Atlantis Group, some in DSD, when approving these projects.

The reason I'm reaching out to you now is because your personal email is on the Form 700 you filed and when situations came up, such as in the Otilie Letter, you were consistently on the side that would shed light on these special treatment issues.

My question to you today is would you be interested in showing your support for a Grand Jury inquiry into the Planning Commission's actions in approving some of these projects over others, the abuse of process in both CEQA and the appeals process which would have tied not only yours but entire Planning Commissions hands on projects that came before you but, again, due to having gamed the system, let projects through that were not even vetted by the Planning Commission.

I realize you are retired from your position and this goes back away but what is highly relevant is how the current investigation and the indictment of Jesus Cardenas, former Chief of Staff to City Councilmember Whitburn and his Grassroots Lobbying group have nexus lines to those in the pay-to-play lobbying and legal representation that make the big picture relevancy to your work while a Commissioner, important to a full disclosure understanding of the process.
