The City of San Diego's motion for summary judgment against Defendant DARRYL COTTON came on for hearing on December 2, 2016, at 10:30 a.m. in Department C-61, the Honorable John S. Meyer, Judge presiding. Deputy City Attorney Onu Omordia appeared on behalf of Plaintiff, City of San Diego. Nathan Shaman appeared on behalf of Defendant DARRYL COTTON.

After considering the moving and opposing papers and hearing oral argument from counsel, the Court GRANTED the City's motion.
THEREFORE, IT IS HEREBY ORDERED that Defendant DARRYL COTTON, his agents, servants, employees, partners, associates, officers, representatives, and all persons acting in concert or participating with or for him are **permanently** enjoined from operating or maintaining a marijuana dispensary, collective, or cooperative in any form at 6176 Federal Boulevard in the City of San Diego without first obtaining all required permits per the San Diego Municipal Code.

IT IS FURTHER ORDERED that pursuant to San Diego Municipal Code section 12.0202(b), Defendant DARRYL COTTON pay the City of San Diego civil penalties in the amount of \$5,000.

The Court will retain jurisdiction for the purpose of enabling any of the parties to this Final Judgment to apply to this Court at any time for such order or directions that may be necessary or appropriate for the construction, operation or modification of this Final Judgment, or for the enforcement or compliance therewith; and,

The clerk of the Court is directed to immediately enter this Final Judgment.
