PLEASE TAKE NOTICE that on February 17, 2023, at 9:00 a.m., Defendant STEPHEN LAKE (“Defendant” or “LAKE”) moved this Court for an order requiring Plaintiff AMY SHERLOCK, an individual and on behalf of her minor children T.S. and S.S. (“Plaintiff” or “SHERLOCK”) to respond to LAKE’s Requests for Production of Documents, Set One (“RFD”) and Form Interrogatories, Set One (“FI”). Further, LAKE moved an award of monetary sanctions against SHERLOCK and her counsel of record in the amount of \$2,820. The Court, having considered the application and evidence submitted by LAKE, the opposition of SHERLOCK, the reply by LAKE, the argument of the parties, review of the record, and with good cause showing, hereby orders as follows:

- 1. LAKE’s Motion is hereby GRANTED.
- 2. SHERLOCK is ordered to provide responses to the Requests for Documents, Set One propounded by LAKE on July 26, 2022 and any responsive documents no later than \_\_\_\_\_.
- 3. SHERLOCK is ordered to provide responses to the Form Interrogatories, Set One propounded by LAKE on July 26, 2022 no later than \_\_\_\_\_.
- 4. Sanctions are awarded against SHERLOCK and/or her counsel of record in the amount of \$ \_\_\_\_\_ and are to be paid to Plaintiff, through its attorney of record, no later than \_\_\_\_\_, 2023.
