Re: San Luis Obispo County, Unlicensed Cannabis Cultivation Operating Under What Appears to be Local Government Acceptance.

## Dear AG Bonta:

As I've stated in my previous two letters, the harm that has occurred to the citizens of California, as a direct result of the passing of Prop 64, has been catastrophic and as Governor, I look forward to the opportunity to repeal it as a void contract and replace it with the Restoration Act. What I would like to do until then is provide you and those other controlling agencies, the information that is coming to me in waves regarding the unlicensed cannabis cultivation operations that I'm being told have local government cooperation. Cooperation that allows these operations to operate openly while others are given the full force of the law with targeted raids and shutdowns. This has all the markings of selective enforcement in pay to play, bribery and corruption schemes that deprive one class of citizens while rewarding another.

As you will see in the enclosures, these are Google Map images, taken within the last 5 days, that show longitude/latitude positions of unlicensed cannabis cultivation whereby I've been told there is no way the local governments can not be aware of it. What I'm also being told, is that there are federal investigations underway that go to local government, pay to play corruption in cannabis licensing. But with what appears to be a statewide, systemic problem, and limited federal government resources, we have no way of knowing what, if anything will ever come of it.

As governor elect, a citizen, and a party in a forth coming state class action lawsuit alleging, inter alia, civil rights violations as a result of Prop 64, I will bring these matters to your attention, on an ongoing, per county basis. I would ask that there be a follow up to confirm or deny the allegations of a quid prop quo relationship as has been alleged with unlicensed cannabis farms and those local government officials that in some cases include law enforcement, who would oversee these types of permits, approvals, and operations.

As I have not had a response to either of my previous two letters I've sent to you, I would respectfully request a response to this letter within 30 days to assure that the proper steps are being taken to remedy what amount to these unlawful conditions.

Thank you for your attention to this matter and in anticipation of your reply I will remain.
